The auditing landscape will experience more changes in the next five to 10 years than it has had in the past five decades, according to a recent EY report CFO Need to Know | The Future of Audit. Data analytics, new technology and access to detailed industry information will all combine to help auditors better understand the business, identify risks and issues and deliver additional insights. In the future, CFOs will be able to rely on a more comprehensive approach to identifying issues, which will allow them to provide better forward-looking perspectives to the CEO and board members. Some key takeaways in the report include: In order to get the most of the audit of the future, CFOs need to select auditors with the knowledge and ability to embed analytics in a way that deepens their understanding of the business and enables them to develop a more forward-thinking audit process that focuses on anticipating future risks. Data analytics will introduce changes to traditional auditing functions in such areas as potential fraud, transaction errors, anomalies in data and breakdown of controls/ineffective controls. The consumer products sector is one area that stands to benefit dramatically from the use of analytics in the audit. Revenue, inventory and suppliers management create a real-time data demand and CFOs in the sector need to adapt to succeed. ...
